## **GUIDELINES FOR MANUSCRIPTS**

# **GENERAL GUIDELINES**

- The name of the file, sent to the journal, must contain the author's surname.
- The article must be at least 25 thousand characters (including footnotes, spaces and bibliography, without References) and shouldn't exceed 50 thousand characters (including footnotes, spaces and bibliography, without References).
- The article must have a clear structure: Introduction (which describes the relevance and novelty of the topic, the aim and goals of the research); the main part (which is divided into several parts and describes methodology and results) and Conclusion (must contain the main inferences and further possible ways of the research).
- If the article doesn't correspond to the guidelines, the board of editors can decline it.

## PREPARING THE MANUSCRIPT

- The text should be in Times New Roman (.doc or .docx), 12 pt, 1.5 spaced and fit to the width, the top and bottom margins should be 2 cm, the left margin 3 cm, the right margin 2 cm.
- The author affiliation must contain the surname, the name, scientific degree, ORCID, e-mail, the name of an organization. If the article is written by several authors, please indicate the corresponding author. Add the UDC information (https://udcsummary.info/php/index.php?lang=en&pr=Y).
- The Abstract should be informative, original, relevant and concise (200–250 words), follow the structure of the paper and contain the following parts: introduction (which formulates the aim, purposes and relevance of the research), methods (which describes material of the article and methods used to analyze it), results (which summarizes the main results of the research), conclusion (which discusses the results and indicates further directions for the research).
- **Keywords** provide at least 5 keywords.
- Figures and Tables. The tables and figures must have captions, for a table the caption must be above it and for a figure below the graphic. The footnote must contain the source of information used in the table or figure. The vertical figures are not allowed. All the figures used in the article must be sent in an Excel file. All illustrative materials (tables, figures, diagrams, diagrams, etc.) must be of good quality and suitable for printing.
- **Formulae** must be created using standard symbols in Microsoft Word.

## REFERENCES IN THE TEXT

- References to other publications in the text must be in Harvard style (For example: [Иванов 2002, 51], [Smith 2018, 40–46]).
- References to newspapers, Internet sources, laws and archive data, PhD thesis must be provided as footnotes: Election results 2019: Which party got the most votes... and other questions // BBC [Internet source]. URL: <a href="https://www.bbc.com/news/election-2019-50779901">https://www.bbc.com/news/election-2019-50779901</a> (accessed: 21.01.2020). Archive data: Центральный архив города Москвы (ЦАГМ). Ф. 1609. Оп. 1. Ед. хр. 529.

## BIBLIOGRAPHY (СПИСОК ЛИТЕРАТУРЫ)

- Bibliography includes scientific works, articles in scientific journals.
- Bibliography must be alphabetically arranged according to <u>ΓΟCT 7.0.5-2008</u>. Works in Russian should be placed first, then works in other languages.
- Bibliography must contain at least 10 scientific works. Using textbooks, handbooks, dictionaries, PhD thesis should be minimized.
- The volume of the bibliography should correspond to the volume of the article and shouldn't exceed 40 works.
- At least 50% of works in the bibliography must be written in last 5 years.
- At least 30% of works in the bibliography must be in foreign languages.
- If a massive reviewing of works that are relevant for the manuscript is necessary, it should be given in a special part (**Literature Review**).
- A massive self-citation is not allowed. Author's previous works can't exceed 40% of the rest of the bibliography.

  - 1. Surname and name
  - 2. Title
  - 3. Place of publishing
  - 4. Publisher
  - 5. Year of publishing

## Works without authors:

Europeanisation in Public Administration Reforms / ed. by J. Nemec. Bratislava: NISPAcee Press, 2016.

- References must include the same works as Bibliography.
- For works in Russian the original translation should be used, which can be found
  in the journal or databases. If there is no such a translation, then <u>transliteration</u>
  should be used.

## HOW TO ORGANIZE REFERENCES

- Monography:
  - 1. Surname and name
  - 2. Year of publishing (in brackets)
  - 3. *The title* (italics)
  - 4. Place of publishing: publisher.

**Examples:** Mabli G. (1950) *Izbrannyve proizvedeniya* [Selected works].

Moscow; Leningrad: Akademiya nauk SSSR.




Figure 1. Spread of the new China virus<sup>1</sup>
